District Plan for Remote Learning if Needed

- WCSD recognizes the importance of having a plan in place in the event it becomes necessary to switch to remote learning.
- Use of social media, Parent Square, and other communications to inform parents, students, and staff of the need for school closure and switching to remote learning.
- Decisions will be based on guidance from DPH, local health officials, CDC, and other state –level officials.
- We currently have 1:1 technology in place for students along with ongoing use of online learning and engagement platforms and resources integrated into the daily learning activities.

FACE-TO-FACE INSTRUCTION

- Face-to-face instruction for all students at all grade levels
- Masking is optional for all students, staff, and visitors
- Meals will be provided in the cafeteria at all schools.
- Increased daily cleaning protocols
- Students fully engaged in all content areas including core subjects, electives, connections, and specials
- Blending of best of pre-COVID and COVID learning tools to create safe, respectful learning environments where students are engaged and challenged
- Focus on grade level learning and accelerating learning where gaps exist in academics and SEL
- Students continue to have technology devices to support independent learning
- Access to before and after school activities in compliance with CDC/GaDPH guidelines.

General Health & Safety Measures

Handwashing and respiratory etiquette

Regular handwashing is one of the best ways to remove germs, avoid getting sick, and prevent the spread of germs to others. Wash hands with soap and water for at least 20 seconds several times throughout the day, especially before and after eating, after sneezing/coughing/blowing nose, after using the restroom and/or if they are visibly dirty.

Covering coughs and sneezes and keeping hands clean can help prevent the spread of serious respiratory illnesses. Cover your mouth and nose with a tissue, if available and throw used tissues in the trash. If you don't have a tissue, cough or sneeze into your elbow, not in your hands.

Cleaning and maintaining healthy facilities, including improving ventilation

Custodial personnel will clean high-touch surfaces daily.

HVAC units are set to allow for maximum ventilation, that all filters are clean, and that all units are working properly.

Coordination with state and local health officials

Student Transportation

Transportation will continue to be provided for all eligible Washington County students. We will continue following best practices standards enacted during the pandemic, along with guidelines and recommendations set forth by CDC and GaDPH.

Safety Measures

All bus drivers and monitors will be trained on safety protocols.

Frequently touched surfaces, including hand railings, student bus seats, and surfaces in the driver cockpit will be sanitized daily.

School Nutrition

Washington County Public Schools will continue to operate under the Community Eligibility Provision in 2023-2024. Breakfast and Lunch will be offered at no cost to all students attending school during the times meals are offered.

Recess

Recess will continue to be held outdoors as long as weather permits.

Use of playground equipment will be allowed.

During inclement weather students will be assigned to indoor spaces for recess.

Facilities

Continued daily cleaning protocols in accordance with CDC and GaDPH guidelines

Ventilation upgrades (HVAC units set to allow for adequate fresh air induction, air filters are changed regularly on all HVAC units)

Hand sanitizer stations throughout buildings and in all classrooms and common areas

Health and safety signage

Floors to be steam cleaned during summer break

Monitoring and Revision

WCSD leaders, local public health leaders, and community stakeholders have a shared interest in ensuring the time, energy, and resources invested to safely return to school is effective. Consequently, monitoring and revising the Safe Return to School Plan is essential for keeping the plan a living and meaningful document. To ensure that consistent monitoring and revision of the priorities, objectives, and strategies of our plan takes place, we will ensure the following:

Involvement and active participation by school personnel, students, parents, and other community stakeholders.
